It is the responsibility of the submitter to verify receipt of the Self-Nomination and Acceptance form by the DEO.

Affidavit of Intent To Be A Write-In Candidate forms must be submitted to the Designated Election Official by **3:00 pm on Monday, March 5, 2018**.

NOTICE IS FURTHER GIVEN, that an application for an absentee ballot shall be filed with the Designated Election Official no later than the close of business on **Tuesday, May 1, 2018**.
